From Sharon, follow Route 343 west to light in Amenia center. Join Route 44 West.
Continue as above

From the Taconic Pkwy, take US 44 exit. Go east on 44 for 1.7 miles. Go left onto Route 44A, east, for 3.2 miles, re-connecting with US 44 east.
Continue 3.2 miles to Bontecou Rd. on the right.
Follow WKC signs to the parking area about 9 tenths of a mile.
